Chairman Whitmore called the meeting to order.

Vice Chairman Holland made a motion to pass the July 2, 2018 agenda; second by Mrs. Palacio. All board members voted aye.

Chairman Whitmore led the Pledge of Allegiance.

Mr. Clark made a motion to approve minutes from the June 6, 2018 board meeting; second by Mrs. Raby. All board members voted aye.

Vice Chairman Holland made a motion to approve June disbursements; second by Mrs. Raby. All board members voted aye.

Mr. Ernie Roles, Jr. requested to address the board concerning alleged inappropriate behavior and bullying regarding his sons Ernie and Ethan Roles and coaches from the Fayetteville City Schools. His request included having his concerns reported in the July 2018 board minutes, wanting to know if his issues have been resolved or are still pending, and submission of his complaint to the State Department of Education. Dr. Wilson read an e-mail sent by Mr. Roles to Mr. Eric Jones stating: he had decided that we do not want to pursue this matter any longer and he thanked Mr. Jones for his kind words given him and his family during this time. Upon receiving a copy of this e-mail Dr. Wilson presumed the matter was over. Dr. Wilson assured Mr. Roles that she would look into the matter further and would come back to the board with a report.

Reports:

Facilities and Transportation – Mr. Perrin reported maintenance will continue in the buildings for the next four weeks getting ready for the new school year. New lockers for FHS were damaged during shipment but will be replaced.

Finance – Dr. Wilson presented Line Item Amendment #1 School Nutrition FY2018 for board approval allocating funds to support year end expenditures. Chairman Whitmore made a motion to approve the amendment; second by Mr. Clark. All board members voted aye.

Dr. Wilson presented Line Item Amendment #1 General Education Fund FY2019 for board approval to fund in-service/staff development for Pre-K personnel. Chairman Whitmore made a motion to approve the amendment; second by Vice Chairman Holland. All board members voted aye.

Dr. Wilson presented the 2017-2018 Surplus and Recycle List for board approval. Mrs. Palacio made a motion to approve the list; second by Mrs. Eady. All board members voted aye.

Mr. Perrin – reported that cafeteria rates for adults will be increased by fifty cents to cover costs and labor.

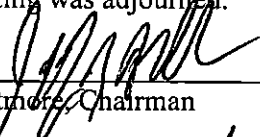

Chairman's Report -

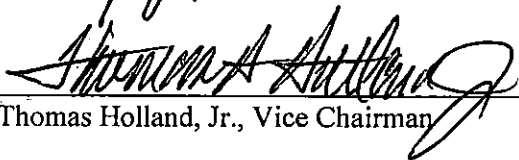
Chairman Whitmore said that the next board meeting will be on August 6, 2018 along with the meet and greet on Tiger Hill.
